Minutes of the meeting held on Monday evening 13/10/2014

1 Croeso / Welcome

Croesawyd pawb i'r cyfarfod gan Derek Owen a diolchwyd i bawb am fod yn bresennol. Esboniwyd mai pwrrpas y cyfarfod oedd trafod cais cynllunio 'Ysgellog 2' (38C301A/EIA/RE).

Derek Owen welcomed everyone to the meeting and thanked them for their attendance. He explained that the purpose of the meeting was to discuss the planning application for Ysgellog 2 (38C301A/EIA/RE).

2 Datgan Diddordeb / Declaration of Interest

Tony Hughes ac felly roedd yn absennol o'r cyfarfod / Tony Hughes and thus he was not present at the meeting.

3 Cais Cynllunio / Planning Application

Dealwyd bod y Clerc wedi anfon copi o'r cryno-ddisg gyda'r dogfennau cynllunio at yr holl aelodau drwy'r post ond nad oedd wedi cael unrhyw sylwadau hyd yma.

Cafwyd sylwadau Marilyn Hughes drwy law'r Clerc yn ei habsenoldeb.

Dealwyd bod Cyngor Tref Amlwch wedi gwrrhwynebu'r cais, a bod Cyngor Mechell yn cyfarfod i drafod y cais 13/10/14. Fe gytunwyd bod angen i gynghorau cymuned leol weithio gyda'u gilydd a chefnogi ei gilydd wrth ystyried ceisiadau am brosiectau mawr o'r fath. Mae gan bob cyngor a'u haelodau gwahanol brofiadau a sgiliau i'w rhannu.

Fe benderfynwyd yn unfrydol i wrwrhwynebu'r cais am y rhesymau canlynol -

- Teimlwyd bod y cais yn gamarweiniol ac mai ym Modewryd mae'r datblygiad nid yn Ysgellog fel mae'r enw yn awgrymu.
- Mae'r Cyngor wedi gwrrhwynebu tyrbinau llai yn y gorffennol ac mae angen bod yn deg wrth ystyried ceisiadau o'r fath.
- Teimlwyd bod y datblygiad yn rhy fawr, ac yn rhy agos i gymuned fechan Bodewryd.
- Roedd pryder am faint y tyrbinau, a'r goleuadau llachar fydd arnynt

It was understood that the Clerk had already distributed copies of the planning documents on CD by post to all members but no response had been received as yet.

The Clerk informed those present of Marilyn Hughes' observations in her absence.

It was understood that Amlwch Town Council have opposed the proposal, and that Mechell Community Council are meeting to discuss the application 13/10/14. It was agreed that local community councils need to work together and support each other when considering such development proposals for large scale projects. Each council and their members have a range of knowledge and experience to share.

It was unanimously agreed to oppose the application for the following reasons –

- *It was felt that the application was misleading and that the development is actually in Bodewryd and not in Ysgellog as the name suggests.*
- *The Council have opposed applications for smaller turbines and there is a need to be fair and consistent when considering such applications.*
- *It was felt that the development is too big and too close to the small hamlet of Bodewryd.*
- *There was concern about the size of the turbines and the bright lights that will be on the turbines.*
